- Go 1/2 miles and turn right (north) to Jester Park Equestrian Center on NW 107th Street.
- Travel 1 mile north to NW 114th Avenue turn right to Jester Park Equestrian Center.
- NW 114th Avenue becomes NW 103rd Ct. Travel 1/2 mile to trial Site
