**GENERAL INFORMATION:** Start time on Friday is 10:00 AM and 8:00 AM on Saturday and Sunday. The building opens at 8:30 AM on Friday and 7:00 AM on Saturday and Sunday.

**CONCESSIONS:** We will have concessions each day!! Lunch will be available on Friday and breakfast and lunch on Saturday and Sunday.

**EXHIBITOR SET-UP:** The building will open at 8:30 am on Friday for exhibitor set up.

**CRATING:** To allow for additional crating space this will be a one-ring trial. The North end of the arena (on dirt) will be available for crating. Please be judicious with space and keep your crating area as small as possible. Crates may be left overnight; however, the DMGRC and the Jester Park Equestrian Center will not be responsible for any lost or damaged items left at the show site.

**COURSE MAPS:** Course maps will be posted by class each morning at <https://caitowenstralsec.wixsite.com/mysite> . Course maps will also be posted at the trial site, but no printed copies will be available. It is suggested to either print copies at home, download them to your phone, or take a picture of them at the trial site.

**CHECK IN:** Will be in the conference room. You may also check in with the Gate Steward prior to the start of the class.

**RIBBONS:** Ribbons will be available for pickup in the conference room once they are released by the judge.

### DIRECTIONS:

From Interstates 35/80 in Urbandale (Northwest DSM):

- Take exit 127 (HWY 141) west (Travel will be northbound) for 5.5 miles.
- Take exit 148 (Hwy 415 / NW Saylorville Drive) to Polk City. Exit right (East) and travel for 1 mile.
- Turn left (West) on NW Beaver Drive towards Jester Park.
- Go 1/2 miles and turn right (north) to Jester Park Equestrian Center on NW 107th Street.
- Travel 1 mile north to NW 114th Avenue – turn right to Jester Park Equestrian Center.
- NW 114th Avenue becomes NW 103rd Ct. – Travel 1/2 mile to trial Site

### Exhibitor Parking & Facility:

Please be courteous and park to maximize the spaces, and follow any posted signs. Please pick up after your dogs and use the provided trash receptacles. **DO NOT permit your dogs to urinate on the building or the like.** Smoking is not allowed anywhere but in the parking lot of the facility, and there are signs showing designated and undesignated areas.

**On-site RV Parking:** The Equestrian Center is now allowing a limited amount of RV parking on-site with no services. You must request a spot in advance.
